 6. Whether any allotment of work / work order is provided to the contractor who is engaged for the purpose of water supply connection in the holding no. 145/1? If so, please furnish a photocopy of the same or any other correspondence which took place between contractor and the SMB in respect of new water supply connection in the holding no. 145/1.
