in W.P. © No. 18 of 2017 and W.P.(C) No, 5618 of 2017.


Sir,

I being one of the Petitioner of above cases, beg to state that as per direction of the Hon'ble Gauhati High Court, Guwahati vide orders dated above, the Silchar Municipal Board shall have to furnish the detailed list, including the names of its employees retired between 01-01-2006 and 01-04-2014 along with the amount they are entitled for revised arrear salary, gratuity of their revised pay and the amount towards their unutilized leave salary. Please find herewith a copy of order dated 24-01-2020 of the Hon'ble High Court which is self explanatory. Several dates were taken by the Silchar Municipal Board on submission of adjournment petitions and time was allowed for the reason that we the petitioners of the cases were not raised any objection against adjournment petitions, The Hon'ble High Court fixed 08-03-2021 again for submission of detailed list of such retired employees before the Court by way of an additional affidavit.

In this respect, I am requesting you to furnish a list of names of retired municipal employees of Silchar Municipality who retired between 01-01-2006 and 31-03-2014 alongwith amount they are entitled for revised arrear salary, gratuity of their revised pay and the amount towards their unutilized leave salary in the form of statement at an early date to me. This application shall be treated as the application under Right to information Act 2005 and the information sought does not fall within the restrictions contained in Section 4 of Right to information Act,2005 and also to the best of my knowledge it pertain of your office.

A fee of Rs.20/- (Rupees Twenty) only has been deposited in your office vide IPO No. 14G 892688 dated 11-02-2021,
