1. Tenderer may drop tender for specific supply of Water Sprinkler – 6000 Ltr. Mounted on 11 Ton Chassis. Specification is enclosed in Annexure 1.
2. Complete Tender document must be submitted in a sealed envelope super scribing (a) Name of work (b) NIT No. & date (c) Name of tenderer with full address and telephone no. & addressed to the Chairman/E.O., Silchar Municipal Board, Silchar-788001.
3. Submission of tender: Prequalification format (Technical Bid) along with all relevant documents/ credential in envelop I, Price Bid with Tender forwarding in envelop II & Earnest Money with cast certificate (if applicable) in envelop III. All three envelop (I + II + III) are to be submitted in a single envelop as mentioned in NIT.
4. Earnest money in the form of Call deposit / FDR, issued by any schedule bank of India, drawn in favor of E.O., Silchar Municipal Board, Silchar-I. Tender without EMD in proper form will be summarily rejected.
5. The Chairman, Tender Evolution Committee /E.O, Silchar Municipal Board, Silchar reserves the right to accept or reject any or all the tenders without assigning any reason whatsoever or split the work suitably among the eligible agencies and is not bound to accept the lowest rates.
6. Suppliers are to quote their rate both in figure and words including all taxes and duties and in case of any correction, in the tendered rates should bear the tenderer's signature.
7. The tender agreement for the supply of Water Sprinkler/Anti Smoke Gun (180 Degree Freedom of Rotation) 6000 Ltr. Water Tank made up of 4 mm Thick MS Plate Mounted on 11Ton Chassis of 20 Ft. CBC Chassis Vehicle” to be supplied and maintained at Silchar Municipal Board, work will be drawn up with the successful tenderer as framed by Municipal with a Non Judicial Stamp of Rs. 20.00. The condition and particulars mentioned in the NIT will be final & binding on the contract/supplier.. The tenderer should therefore sign each page of bid document as token of acceptance of condition stipulated therein and attach the same along with tender submitted by them.
8. The undersigned reserves the right to modify the specification during signing of agreement.
9. The authority is not liable to pay any interest for any delay in payment.
10. If the successful tenderer withdraw his tender or refuse to sign the agreement in any pretext whatsoever within the period between the date of issue of work order by the Authority and the date given for signing formal agreement by him, his earnest money is liable to be forfeited. The selected tenderer will have to sign the formal agreement as framed by Municipal Authority in Municipal norms with a Non Judicial Stamp of Rs. 20.00 within three days from selection order.
11. The amount quoted should be inclusive of all Taxes and duties.
12. The amount quoted by the contractor will be valid for entire supply period of the work and execution of price will not be entertained.
13. The Earnest Money will be returned to tenderer on written application within 28 days from the date of issue of work order, who's tender, is not selected for acceptance. The earnest money of

the successful tenderer will be retained as part of security deposit described in the following paragraph.

14. Pre bid meeting with the Authority is considered to be appropriate for bidding.
15. The tender will be opened on schedule date & time in presence of supplier / agency or their authorized agent. Envelope containing EMD will be opened first. If the EMD is found in proper form, envelope containing technical bid will be opened. The financial bid of supplier / agency will be opened at the schedule time after necessary verification of the papers submitted by the tenderer along with technical bid.
16. All disputes arising out of the processing of offers and of the supply order of intent so made shall be subject to jurisdiction of Silchar Civil Court. After supply of vehicle if any part is found to be of sub standard quality then it shall have be replaced/modified as directed by the authority. If any deviation found from departmental specification it has to be replaced or make good by the supplier at his own cost and liability.

Additional Eligibility Criteria:-

- The tendering firm/company may be a manufacturer/authorized dealer and should be duly registered with appropriate authority.
- The tendering firm/company must be ISO 9001: 2015 certified company.
- The Manufacturer/Bidder should have supplied at least 5 No.s of similar machines in the last three years ending on the last date of submission of this tender. Similar machines shall mean truck mounted water sprinkler/super sucker machines
- The Bidder should have experience of having supplied similar machines in the North-East Region
- The Bidder should have an average turnover of minimum 10crore per annum for the last three years. ITR Copies with Turnover Certificates to be attached as proof of the same.
- The Manufacturer/Bidder shall be compulsorily required to submit an undertaking/affidavit stating that they are not under blacklist and have no pending litigation at the time of submission of bid, in any government/semi-govt./PSU's or any other govt owned subsidiary.

SCOPE OF SUPPLY :-

- The bidder shall be required to provide service throughout the warranty period and shall be responsible for service of the complete chassis and machinery – 03 No's.
- The bidder shall be required to deploy one full time mechanic at Silchar who shall initially train the operators/drivers of Silchar MB for a period of 2 Month and later be available as per requirement.
- The bidder shall be responsible for delivery of the machinery ex works Silchar.
- The bidder shall be responsible for all costs pertaining to initial insurance, Registration Charges and allied costs associated with getting the machinery registered and working.
- The supplied machinery shall have proper logo and stickering as per the requirement of Silchar MB.
- The delivery period shall be of 20 Days from the date of release of supply order.

Payment Terms :-

1. The lowest bidder shall be required to submit a Performance Bank Guarantee of 3% of the contract value upon issue of LOI and the same shall remain valid for the entire period of this contract
2. Upon submission of the PBG the bidder shall be refunded his EMD
3. Full payment for the supplied machinery shall be made upon receipt & successful running of the machinery for a period of 15 Days which shall be calculated from the date of receipt of the machinery
